# Sub: Minutes of meeting held with Members of G-Block Association and BKC Property Owners Association regarding Celebration of Republic Day-26<sup>th</sup> January 2015.

1) A meeting was convened under the Chairmanship of Metropolitan Commissioner, Mumbai Metropolitan Region Development Authority with the representatives of G-Block Association and BKC-Owners Association at 3.00 pm on Monday the 29<sup>th</sup> December 2014 to discuss the modalities of celebration of "Republic Day-26<sup>th</sup> January 2015".

2) The list of attendees is kept at Annexure-I.

3) At the outset Joint Project Director (Town Planning) made a presentation on "Republic Day celebration"- 26<sup>th</sup> January 2014. The Metropolitan Commissioner mentioned that the event was well received by all *Mumbaikars* and it is expected that this year celebration will take place on more grand scale with the participation of maximum corporate houses and institutions in Bandra-Kurla-Complex (BKC). He then invited suggestions from those present to make this "26<sup>th</sup> January 2015 Republic Day" Celebration a spectacular event.

4) Mr. Puneet Saxena, Chairman of G-Block Association suggested to take up the "Clean BKC Campaign" as a preceding activity to the Republic Day celebration. This idea was well received by all the representatives and it was decided that a week prior to Republic Day i.e. 19<sup>th</sup> January to 23<sup>rd</sup> January 2015 shall be observed as "Clean BKC Campaign" during which all the plotholders shall not only clean their own premises but shall also clean their neighborhood including the streets, gardens, Medians, footpaths around their buildings. (Action: Both Association's)

5) This will also be supported by MMRDA by taking mass scale- cleaning action of public areas, M.C. MMRDA directed Executive Engineer, MMRDA to undertake painting Kerb stones, and cleaning road and footpaths and completing the balance reinstatement works. The Engineering Division of MMRDA was directed by the M.C., MMRDA to undertake clean operation with immediate effect and ensure that Bandra-Kurla-Complex area looks Spick-and-Span. (Action: Chief Engineer, BKC, MMRDA)

6) One of the suggestions was also made to run decorative BEST Buses from Bandra, Kurla and Sion Stations to BKC during 4.00 pm to 11.00 pm on 26<sup>th</sup> January 2015. The decoration of buses shall be made by MMRDA by hiring an agency and buses will be run free-of-cost by BEST. A request letter to this effect will be sent by MMRDA to BEST. As desired by these representatives, MMRDA shall request to BEST to make available around 10 Open-Deck-Buses. (Action: JPD-TP, MMRDA)

7) One of the suggestions was to have Cricket Matches between teams of Corporate Houses located in Bandra Kurla Complex. The week proceeding 26<sup>th</sup> January 2015 will have competition between Corporate Cricket Teams, and the Winner Team will be awarded during the celebrations of 26<sup>th</sup> January 2015. The organization of this tournament will be done in assistance with Mumbai Cricket Association Club by BKC Property Owners Association and G-Block Property Association. The programme will be finalized shortly during the successive meetings of both the Associations. (Action: Both Associations)

8) It was decided that decorative lighting of the individual buildings shall be done by all the plot-owners. Apart from decorative lighting of individual buildings, lighting and decoration of common areas shall also be done as common activity. This will be coordinated by the G-Block Association and Property Owners Association with individual buildings and common area lighting will be done by contributory approach co-ordinated by both

Associations. Both the Associations will coordinate with individual Institutions. (Action: Both Associations)

9) M/s. Reliance Energy will be requested to provide electricity in this area for common area lighting free of cost and that will be considered as their contribution towards this event. MMRDA will request Reliance Energy for the same and both Associations will co-ordinate with the Reliance Energy further. (Action: JPD-TP, CE, Both Associations)

10) MMRDA will also request Reliance Energy to recolor the electric poles and to repair faulty lamp posts in Bandra Kurla Complex. (Action: JPD-TP, CE, MMRDA)

11) The Central Medians where landscaping has been done by different sponsors shall be requested to undertake trimming operation and cleaning of Central-Medians, Recreation Ground and the traffic Island with fountains. All the fountains need to be in working condition and shall be operated for the entire week i.e. 19<sup>th</sup> to 26<sup>th</sup> January 2015 from 8.00 am to 10.00 pm. MMRDA to write to the Sponsors regarding the same. (Action: JPD-TP, MMRDA)

12) It was also decided that Corporate Houses, Banks, Financial Institutions etc. who have engaged Celebrities as their Brand-Ambassadors should invite them in the evening function on 26<sup>th</sup> January 2015 as added attraction to the event. (Action: Both Associations)

13) It was also decided that evening function shall be on a grand scale and the families of all the employees working in BKC shall be invited by the respective organizations for the said programme. (Action: Both Associations)

14) The evening event should also have elements like Fire works, Laser show, live patriotic music and patriotic performances etc. The Laser show and Fire-works will be additional attraction of the Republic Day Celebration. Both the Associations agreed to co-ordinate and make the event very successful as decided above. (Action: Both Associations)

15) It was decided that every institution may like to contribute towards National Celebration and it should not be left to individuals but institution shall come forward to support this cause. Metropolitan Commissioner, MMRDA agreed to write a D.O. letter to Chiefs of all the institutions soliciting their participation in the Republic Day Celebration in Bandra Kurla Complex. (Action: JPD-TP, MMRDA)

16) It was also decided that next follow up meeting of the representatives will be held on 8<sup>th</sup> January 2015 at 3.00 pm at MMRDA. Before this, both the Associations shall meet and come up with a concrete programme for celebration of Republic Day 2015. (Action: JPD-TP, Both Associations)

17) The Associations also requested MMRDA to invite Hon. Chief Minister and Hon. Chief Secretary to grace the Republic Day Celebration in the Bandra-Kurla-Complex. MMRDA agreed to make such request. (Action: JPD-TP, Both Associations)

The meeting ended with thanks to the Chair.
