**ELIGIBILITY :** For award of work, the following is required:

1. The bidder shall have valid registration & License issued by Govt. of Maharashtra's competent authority to carry out the work.

2. Average Annual financial turnover during the last 3 years, ending at 31<sup>st</sup> March of the previous financial year, should be at least 80% of the estimated cost.
3. Experience of having successfully completed one similar work costing not less than the amount equal to 80% or two works costing 50% or three works not less than 40% of the estimated cost during previous 5 years.

**Note:**

- i) The work of providing annual maintenance of electrical installation carried out under single work order in Govt./ Semi Govt. Organization in MMR shall be treated as a similar work.
- ii) Certificate of satisfactory completion of similar work shall be issued by officer not below the rank of Executive Engineer. The copy of such experience certificate shall be uploaded by the bidder in e-Envelope 'B' Technical Bid.
- iii) Bids from joint venture are not permitted.
