Mode of Selection: Appointment shall be made by Selection or on deputation from Railways / Metro Railways/ Major Companies of PST working in Railways/ Metro Railways, from amongst the candidate who possess the following:

Qualification: The applicant should be a graduate of Electrical/ Electrical & Electronics or any other Engineering degree in relevant field i.e. Power Supply Traction — with good academic record from a recognized University/ Institution of repute. Preference will be given to candidates belonging to Indian Railway Service of Electrical Engineers (IRSEE). Experience: Minimum 7-year experience in Installation, Testing & Commissioning / Maintenance in Power Supply Traction in Railway/ Metro Railway or similar nature of experience of Transmission Lines and substations in other organizations.
