6. Payment terms: Offer to be marked in favour of: Mumbai Metropolitan Region Development Authority. 100% payment shall be released within 30 days against the delivery and acceptance of material at Mumbai Monorail Wadala depot.
7. The quotation shall be addressed in the name of: Mumbai Metropolitan Region Development Authority.
8. Liquidated Damages- In case the supply/completion of work is delayed from Seller Ex-works / Seller as per delivery schedule as mentioned in the purchase order due to the reasons solely attributed to the seller/supplier, the supplier shall be liable to pay the liquidated damages i.e. LD @ 0.5% for every 7 calendar days of delay, subject to maximum upto 10% of total purchase order value. Liquidated Damages shall be deducted from any amount payable to the supplier.


