2. The quotation must be addressed to Mumbai Metropolitan Region Development Authority.
3. Rate quotes shall be valid for a period of 3 months.
4. Price basis: DDP Monorail Dcpot, Wadala, Mumbai.
5. Delivery Schedule: Shall be mentioned in the quotation.
6. Warranty Terms: Minimum 01 year against the date of supply of the material.
7. Payment terms: 100% payment within 30 days against delivery and acceptance of material at Mumbai Monorail alongwith Compliance of GSTR 1 and GSTR 3B returns upto the preceding month of the invoice.
8. Liquidated Damages- In case the supply/completion of work is delayed from Seller as per delivery schedule as mentioned in the purchase order due to the reasons solely attributed to the seller/supplier, the supplier shall be liable to pay the liquidated damages i.e. LD @ 0.5% for every 7 calendar days of delay, subject to maximum up to 5% of total purchase order value. Liquidated Damages shall be deducted from any amount payable to the supplier
9. Shipment documents in Original: Tax Invoices, Delivery Challan / E-way bill, packing list, etc. as applicable.
10. The selected bidder must get the technical clearance from RST department of Mumbai Monorail by submitting a sample of each item prior to delivery of complete lot.
11. The name of work & reference no. shall be written on the sealed envelope.
12. Vendors shall quote for all the items. Incomplete quotations will be rejected.
13. Quotation opening date: From August 5th, 2022 to August 11th, 2022 (Time – 3:00 PM).
