5. Delivery Schedule: Shall be mentioned in the quotation.
6. Warranty Terms: Minimum 12 months against the date of supply of the material.
7. Payment terms: 100% payment within 30 days against delivery and acceptance of material at Mumbai Monorail alongwith Compliance of GSTR 1 and GSTR 3B returns upto the preceding month of the invoice.

Liquidated Damages- In case the supply/completion of work is delayed from Seller as per delivery schedule as mentioned in the purchase order due to the reasons solely attributed to the seller/supplier, the supplier shall be liable to pay the liquidated damages i.e. LD @ 0.5% for every 7 calendar days of delay, subject to maximum up to 05% of total purchase order value. Liquidated Damages shall be deducted from any amount payable to the supplier.
