3. The blank tender forms will be issued only on production of attested copies (along with the original for verification) of following documents:-
 - a) Valid Registration Certificate.
 - b) VAT registration no. & certificate.
 - c) The prospective bidder should have achieved in the last three years i.e. 2010-11 to 2012-13.
 - i. At least two financial years, a minimum annual financial turnover (in all classes of Civil Engineering Construction works only) not less than 75% of the Estimated cost put to tender as shown in Column No.3
 - ii. Satisfactorily completed single work of amount put to tender **OR** two similar works each amounting to not less than 50% amount put to tender in Govt. / Semi Govt. organization.
(Certificate issued by an officer not below the rank of Executive Engineer in this regard shall be mandatory.)
4. Cost of Blank Tender Form as per Column No.7 is to be paid by Pay – Order / Demand Draft, payable in the name of ‘MMRD Fund’ payable at Mumbai and drawn on any nationalized or Scheduled Bank.
5. A Pre-bid meeting for the works will be held on 14/10/2013 at 11.00 hrs in the office of Chief Engineer.
6. Right to reject any or all tenders without assigning any reason thereof is reserved.
7. The offer shall remain valid for a period of 120 days from the date of opening of the tender.
8. Only one copy of tender will be issued to the contractor.
9. Any type of influence during the process of tendering shall disqualify the tenderers from submission of his offer and further processing of his offer.
10. Joint ventures shall not be allowed.
11. The bidder must have a balance bid capacity worked out as per relevant formula given in tender documents.
