Holidays) on payment of Rs. 10,000/- (Non Refundable) for Metro Rail corridor (Versova-Andheri-Ghatkopar Metro Corridor) in the form of D.D./P.O. in favour of "MMRD fund" drawn on any Nationalized/ Scheduled Bank payable at Mumbai or Banks promoted by All India Financial Institution viz. ICICI Bank, HDFC Bank, AXIS Bank, IDBI Bank payable at Mumbai and on production of attested copies (along with originals for verification) IT, PAN, VAT Registration and Documents as per eligibility mentioned below:

## **Eligibility:**

- 1. The agency must be a company registered under The Companies Act, 1956.
- 2. The agency should be in the field of Outdoor Advertising for at least three years having experience in the field of Advertising on public facilities like FOB, Bus Shelter, Skywalk, Rail/Bus Terminals/Stations, Public Gardens, shopping malls etc. with adequate facilities, Illumination, public information display for a period not less than 3 years in any city in India or abroad.
- 3. The agency should also produce solvency certificate to the tune of Rs. 2.00 Cr.
- 4. Agency should have minimum average Annual Turnover of Rs.5.00 Cr. for last 3 years.
- 5. To meet the eligibility criteria at (2) above, Joint Venture of not more than 3 firms is permitted and each of the Joint Venture partner shall meet criteria (3) and (4) above.
- 6. The Bidders shall have their office in Mumbai and shall be required to operate the work from Mumbai.

### **Selection Criteria:**

i) The selection will be based on responsive Bidder quoting highest premium, the successful bidder shall pay maximum quoted premium to MMRDA in three annual installments, one month prior to the beginning of each financial year. The successful bidder shall have to pay all taxes, charges etc. as applicable on advertisements etc. The minimum upfront premium will be Rs. 15.0 Cr.

marked "Technical proposal" will be opened by the Chief, T&C Divn. or his

authorized representative in his office on the same day at 1530 hrs. if possible. The

time and place for opening of financial proposal will be communicated at a later

date. Proposal without submitting EMD will be nonresponsive.
