The bidder shall have experience of successfully completing at least one single similar work of amounting not less than to **Rs. 60.00** Lakhs or 80% of the estimated cost which ever higher carried out in Govt./ Semi Govt. Organization during last **five** financial years. Certificate of satisfactory completion of similar works shall be issued by officer not below the rank of Executive Engineer.

**Note:**

- i) Construction of GI sheet fencing/compound wall/Building construction/road construction or maintenance work etc. shall be treated as a similar work.
  - ii) The weightage for updating of costs will be done @ 10% p.a. to arrive at 2013-14 prices. While updating costs in this manner, the total cost of completion only will be updated based on the year in which the work is completed.
2. The bidder shall be registered in PWD/Irrigation/Govt/Municipal Corporations in appropriate category.
