- iii) Joint venture shall not be allowed.

- Eligibility:- i) The Annual Turn over of the bidder for last 5 years, work experience, availability of machinery & manpower etc. shall be as mentioned in the tender document.
 - ii) For work at sr.no.1, the bidder should have successfully completed minimum one similar type of work i.e.Construction or routine maintenance of Civil Infrastructure works such as roads, Sewer, SWD lines etc. in MMR region costing not less than Rs.3.20 **Crore** (as a single work only) in any of the year preceding last five year.
 - For work at sr.no.2, the bidder should have successfully completed the Construction or routine maintenance of Civil Infrastructure works such as roads, Sewer line ,SWD lines etc. in MMR region costing not less than Rs.60.00 Lacs (as a single work only) in any of the year preceding last five year.
 - For work at sr.no.3, the bidder should have successfully completed at least one similar type of work i.e. Desilting of SWD line & Sewer chambers in Mumbai City or Mumbai Suburban district costing not less than Rs.15.00 Lacs (as a single work only) in any one of the year of last five preceding years. Note:- For updating 5% of work completion amount will be escalated for every financial year to bring it to 2012-13 level
 - v) Work Completion certificates shall be attested not below the rank of Executive Engineer
 - In case of work carried out in JV, Contractor shall attach certificate showing magnitude of quantity & cost of work apportioned to his credit certified by the officer not below the rank of Executive Engineer.

- i) Any type of influence during the process of tendering shall disgualify the tenderer from submission of his offer and further processing of his offer
- ii) Right to reject any or all tenders without assigning any reasons thereof are reserved with the authority.
