The minutes of the 145th, 146th and 147th Meetings of the Committee, held on 22nd October, 1992, 3rd November, 1992 and the 10th November, 1992, respectively, were confirmed.

2.1. While considering the action taken report on the study of "alternative fuels for Public Transport in Greater Bombay to reduce automobile pollution" (Item No.1 of the minutes of the 145th meeting of the Committee held on 22nd October, 1992), Shri C.M. Correa emphasised that the Scooters and Auto-Rikshas are major sources of pollution and noise. The study of alternative fuels must, therefore, specifically look at the possibility of using electricity as the energy for <u>two</u> and <u>three</u> wheelers. It was agreed that at the time of negotiations with the selected Consultants for the study, this aspect may also be included in the scope of the work.

2.2. The action taken report was then noted by the Committee.

ITEM NO. 3: Construction of a bridge across Mithi River on the Bandra-Kurla Link Road in Bandra-Kurla Complex - Approval to the tender for the Mithi Bridge.

While introducing this Item, various possible reasons for the first lowest tender offer being above the block estimated cost by 58.94% were explained. Shri Shirish Patel therewoon mentioned that though the various reasons identified for excess are justifiable, the estimates should have been more realistic and as far as possible should have taken into consideration such aspects of specialised constructions. The Committee then approved the proposal

"RESOLVED THAT in exercise of the powers conferred under Section 7(3)(iii) of the BMRDA Act, 1974, the Executive Committee hereby accords its general approval to the lumpsum offer of M/s. Michigan Engineers Pvt. Ltd. amounting to Rs.5,75,00,000/- for the construction of a bridge across Mithi River, on Bandra-Kurla Link Road, being accepted, as proposed.

"RESOLVED FURTHER THAT the Metropolitan Commissioner be and is hereby authorised (i) to negotiate the lumpsum bid quoted by M/s. Michigan Engineers Pvt. Ltd. to lower down the cost, if found feasible and (ii) to entrust the work to M/s. Michigan Engineer Pvt. Ltd., as proposed in the Item Note."

ITEM NO. 4: Development of International Finance and Business Centre (IFBC) in Bandra-Kurla Complex.

4.1. The Metropolitan Commissioner explained the need and concept at IFBC and highlighted the opportunity of developing such a centre in Bandra-Kurla Complex.

Reacting to the proposal, the Chairman doubted whether 4.2. a truly International Financial Centre similar to New York, Tokyo or London would be feasible in Bombay in the foreseeabl future. He felt that what was perhaps feasible was a Nationa Financial Centre which would facilitate bilateral trade and financial transactions with other countries. He suggested that before we commit ourselves to the development of such a Centre, the idea should be explored thoroughly with the Supporting his views, help of experts in the field. Shri Charles Correa observed that good life-style and good living conditions in the City are essential for development of such an International Centre in Bombay. He said that if incentives, such as those available in the export processing zone could be offered to those establishing their offices in the International Finance & Business Centre and provision for good housing, transport, etc. is made, such a Centre would be successful. A package on these lines could perhaps be offered somewhere in New Bombay.

4.3. Shri Shirish Patel suggested that if a development of second business centre was being considered for Bombay, it would be desirable to consider alongwith Bandra-Kurla Complex, a location in New Bombay for such a Centre. Shri D.T. Joseph, Secretary, Urban Development, did not favour a suggestion in the Agenda note to use for the proposed International Finance & Business Centre the land earmarked for textile market in Bandra-Kurla Complex. He said that this would amount to giving up the proposal to relocate the textile market and would sericusly compromise the policy of decongesting South Bombay.

4.4. After some more discussion, the Committee approved in principle the concept of developing an International Finance and Business Centre. The Committee, however, suggested that in addition to Bandra-Kurla Complex, New Bombay should also be considered as a possible location for such a Centre. The Committee also approved further course of action as stated in sub-paras 'a', 'b' and 'c' of para.8 of the agenda note, and authorised the Metropolitan Commissioner to take further necessary action in the matter.

ITEM NO. 5: Bombay Trans Harbour Link Project (BTHL Project).

During the course of discussion on this Item, the following suggestions were made :-

- (i) The scope of the feasibility studies for both the alternative routes (Southern & Northern) should be exactly the same.
- (ii) It is necessary to consider the safety of the operations of the Bombay and Jawaharlal Nehru Ports etc. and to carry out risk analysis for both the sites.
- (iii) The study should cover proposals for efficient dispersal of traffic on both the sides of the two alternative sites to connect the existing/ proposed arterial roads including the proposed Eastern and Western freeways.
 - (iv) The comparative evaluation should also deal with the implementation problems for the two sites in details.

(v) The Consultants should be asked to give breakup of cost quoted for the study for the components of Northern link, Southern link and the comparative evaluation.

The Committee then passed the following Resolution :-RESOLUTION NO.564 :

"RESOLVED THAT the draft Terms of Reference (TOR) for the consultancy assignment for preparing engineering feasibility report studies including financial/economic viability as a BOT (Build, Operate and Transfer) Project and other allied aspects like environmental, legal and organisational matters etc. for the two alternative link alignments of Bombay Trans Harbour Link Project, as per Annexure to the Item Note be approved subject to incorporation of various suggestions made during the course of discussion on the Item.

"RESOLVED FURTHER THAT the TOR as approved by the Executive Committee be submitted to the Authority for its consideration with reference to Authority's Resolution No.521 adopted at its 65th meeting held on 11.8.1992.

"RESOLVED FURTHER THAT the Metropolitan Commissioner be and is hereby also authorised to take further action for short-listing of the Consultants for carrying out the study as proposed in the Item Note."

ITEM NO. 6: Application from M/s. Glaxo India Ltd., for clearance under Industrial Location Policy.
