Item No.l : Confirmation of the minutes of the last (166th) meeting of the Committee.

The minutes were confirmed.

Item No.2: Action taken on the minutes of the last (166th) meeting of the Committee.

2.1.1 Referring to action taken report in respect of Item No.6, viz. "Financial assistance to Thane Municipal Transport (TMT) for bus fleet augmentation", the Metropolitan Commissioner informed the meeting that as pe general decision taken regarding interest rates to be charged by BMRDA for various purposes, interest rate of 15% per annum was chargeable to semicommercial activities such as bus transport, etc. and as such the same rate of interest would have to be charged to TMT, instead of 12% as sanctioned under Executive Committee's Resolution No.652. He also informed the Committee that interest rate of 15% per annum was proposed in respect of similar financial assistance proposed to be given to the Navi Mumbai Municipal Corporation (NMMC) which Item was also placed before this (167th) Meeting of the Committee vide Item No.5.

2.1.2 The Committee agreed with the Metropolitan Commissioner's suggestion and decided that in partial modification of Committee's Resolution No.652, the

2.2.1 Shri D.M. Sukthankar then enquired of the further action taken in respect of Item presented by CIDCO the 164th meeting of the Executive Committee held at 30th August, on 1995 regarding .construction of 3 multi-purpose dams on rivers Gadhi, Kasadi and Ulwe, which are essential for controlling floods to Panvel town and surrounding areas being developed by CIDCO such as Kharghar and Kalamboli, which dams would also yield about 700 mld. of water, for urban water supply.

2.2.2 After discussion, it was decided that CIDCO should send a note to all the members of the Executive Committee, Irrigation Department and other concerned agencies and obtain their views in the matter. After the views are received, CIDCO should present a detailed Item Note to the Authority and Government.

2.3 The action taken report was then noted by the Committee.

Item No.3 : Urban Infrastructure Development -Need for a Financial Intermediary.

3.1 The proposal presented to the Executive Committee in terms of the revised structure of the financial intermediary and contributions of BMRDA to the Trust Fund and Asset Management Company were approved.

3.2 It was emphasised that given the size of Trust Fund of Rs.150 crores it would be important that large projects would still be eligible to directly access the World Bank Fund. The World Bank should not treat the financial intermediary as the single window through which all World Bank finances would be routed for infrastructure development in Maharashtra. It was also suggested that the World Bank assistance financial intermediary should to the be obtained as a line of credit not tied down to a particular project.

Subject to the above suggestions, 3.3 the Metropolitan Commissioner was authorised to request the Government of Maharashtra to formally submit proposal to the Department of Economic Affairs, the Ministry of Finance, Government of India through Ministry of Urban Affairs & Employment with а view to. obtaining World Bank concurrence to the proposed structure of the financial intermediary and an assurance principle to support the infrastructure in loans portfolio of the proposed financial intermediary.

It was also decided that the legal formalities should be studied by the Legal Adviser, BMRDA in consultation with legal departments of financial institutions and suitable documents got prepared for approval of the Government.

Item No.4 : Grant of loan to Public Works Department for construction of Second Thane Creek Bridge and ongoing three flyover works.

The Committee approved the proposal contained in the Item Note and passed the following Resolution:-

RESOLUTION NO. 657 :

"RESOLVED THAT in exercise of the powers conferred under Regulation No. 7.1 of the BMRDA (Grant of loan from Reserve Fund) Regulations, 1992 the Committee hereby accords post-facto Executive sanction for release of further loan of Rs.5.00 crores at 14% interest for the construction of Second Creek Bridge and release of Rs.3.774 crores Thane for ongoing works of three flyovers which is interest free to Public Works Department as proposed."

Item No.5: Grant of loan to Navi Mumbai Municipal Corporation for purchase of buses.

The Committee approved the proposal contained in the Etem Note and passed the following Repolution:-

RESOLUTION NO. 658 :

that in exercise of the "RESOLVED powers conferred under Regulation No.7.1 of the BMRDA (Grant of Loan from Reserve Fund) Regulations, 1992, the Executive Committee hereby accords its approval to grant to the Navi Mumbai Municipal Transport Undertaking (NMMTU) of the Navi Mumbai Municipal Corporation (NMMC) a loan of Rs.10 crores for purchase of buses, subject to the following conditions :-

- i) The loan will carry interest of 15% per annum to be repaid within 5 years;
- ii) Prior approval of General Body of NMMC be obtained and produced to BMRDA;
- iii) Government in Urban Development's sanction to borrow loan from BMRDA be obtained and produced to BMRDA;
- iv) Executing a suitable agreement with BMRDA; and
- v) The buses purchased out of the loan be hypothecated to BMRDA as security.

"RESOLVED FURTHER THAT the Metropolitan Commissioner be and is hereby authorised to take further necessary action including release of loan in suitable instalments taking into account the requirements of funds of NMMC as well as availability of funds in the Reserve Fund to implement the Resolution."

<u>Itom No.6</u>: Emproving Infrastructuro -Making funds available to Public Works Department (PWD) from BMRD Fund -Recommendation to the Authority.

6.1 During the course of discussion it was emphasised that most of the works for which the Public Works Department (PWD) had requested loan were outside the projects identified by W.S. Atkins Comprehensive Transport in Study for Bombay Metropolitan Region (BMR) and that BMRDA should channelise the investment as per priorities set out in the said study.

It was clarified in respect of the above, that the W.S. Atkins Study had recommended improvement of Western/Eastern Express Highways and Sion-Panvel Road including improvement of junctions.

6.2 After discussion, it was decided that the PWD proposal might be reexamined in the context of recommendations of Atkins Study and resubmitted in the next Executive Committee meeting.

Item No.7 : Financing MCGB's III-A Bombay Water Supply Project by BMRDA.

Itom No.8 : Organization study of BMRDA.

8.1.1 The Metropolitan Commissioner explained that initially the Metropolitan Authority comprised three Committees, viz. the Authority, the Standing Committee the Executive Committee. The Authority had and 46 The office of the Metropolitan Commissioner members. was organised in three Functional Boards dealing with Housing, Urban Renewal & Ecology; Transport & Communications and Water Resources Management. 1983, the Functional Boards and the Standing In Committee were disbanded and Authority with limited membership and Executive Committee with three nonofficial experts were reconstituted by amending the 8MRDA Act. Since 1983 considerable changes occured the functions of BMRDA. For example, in the infrastructure financing role is acquiring increasing importance. Similarly, the 74th Constitutional Amendment had redefined the respective roles of local authorities and the metropolitan authorities. Participation of NGOs in the planning process is also acquiring increasing importance.

8.1.2 In this context the Metropolitan Commissioner stressed the need of undertaking an exhaustive organisation study to redefine the mission of BMRDA and accordingly strengthen its organisation and establish improved administrative and procedural practices.

8.2 The need for carrying out the study and the Terms of Reference presented to the Executive Committee were generally approved, subject to the condition that the duration of the study should be limited to 16 to 20 weeks.

8.3 The shortlist of the Consultants was also approved subject to replacement of Administrative Staff College, Hyderabad by Arthur Anderson, Mumbai.

8.4 As regards suggestion made by Shri Shirish Patel of setting up of Technical Appraisal Committee to assist the Executive Committee, it was decided that this suggestion could be considered as a part of the organisation study and decision made only after the report of the Consultant is available.

8.5. The Executive Committee, thereafter, passed the following Resolution :-

Item No.17 : Study for Development of Comprehensive Transportation Plan for Bombay Metropolitat. Region (BMR) by M/s. W.S. Atkins.

17.1 While placing the Item before the Meeting the Metropolitan Commissioner stated that the recommendations of W.S. Atkins were presented to the Executive Committee in the past. Thereafter BMRDA had arranged 3 seminars know the to views of officials, NGOs, environmentalists and interest groups such as WIAA, industries, etc. Metropolitan Commissioner requested the The Executive Committee to discuss the subject and approve the investment proposals.

Shri N.V. Merani observed that in the past cabinet 17.2 had already approved the recommendations of the Paranjape Committee about prioritisation οf projects οf Traffic Transport improvements in BMR. æ He also suggested tha the constructive suggestions made in the seminars, particularly about outer areas of BMR and Island should also be circulated along with the City areas,

report to the concerned authorities, etc.

The Special Inspector General of Police (Traffic) 17.3 emphasised the need to take up short term projects on priority irrespective of World Bank's loan and also suggested that the major recommendations about demand Management need to be endorsed by the cabinet. 1100 further expressed the need to strengthen Traffic the Department Municipal Corporation of Greater of Bombay (MCGB) ٥r make alternate interim arrangement for implementation of the recommendations.

17.4 The Managing Director, CIDCO and Shri R.Y. Tambe tett that the priorities of investment proposals given in the report should be finalised in consultation with implementing agencies in Bombay Metropolitan Region and it should be further ensured that investment decisions are made according to the agreed priorities.

17.5 Secretary (TPWSS) to Government, The Urban Development Department pointed out that due to change Rules of Business in the Government of India, even in at State level Urban Development Department is expected to handle urban transport issues for which it was not adequately staffed and therefore there was a need for a Transport Policy at Government of Maharashtra level for all urban areas in Maharashtra. He further stressed the importance of demand management measures such ลฮ staggoring of office hours; development of off street parking lots, etc.

17.6 The Railway Adviser, BMRDA pointed out that some sort of commitment from Railway Board/Ministry was necessary otherwise Railways were announcing schemes/ studies notwithstanding MUTP-II.

17.7 Summarising the discussion the Chairman, Executive Committee observed that though officers from different agencies were consulted and were aware of the Atkins recommendations, it was necessary to obtain the agencies/ department's formal views/comments on the recommendations before obtaining policy directives from the Government.
