The gist of the meeting and decision taken is as follows:

- (1) M/s. Reliance Energy shall take colouring of all Electric Poles in Bandra Kurla Complex
- (2) M/s. Reliance Energy shall undertake the repairing of lamps in Bandra Kurla Complex.

- (3) Necessary tree trimming operation for proper illumination will be taken by M/s. Reliance Energy in consultation with the competent authority/ MCGM /MMRDA / Traffice police etc.
- (4) Regarding providing power supply on complimentary basis as contribution to Republic Day celebration by M/s. Reliance Energy. for area lighting/ Central Median lighting/ Festival lighting for Republic Day, M/s. Reliance Energy will make assignment of power load and come-back with the approval of their Management on 9th January 2015 during review meeting proposed by MMRDA.
- (5) The reinstatement of the Roads in Bandra-Kurla-Complex dug up by Reliance Energy for Street lighting will be taken by MMRDA at MMRDA's cost as per the agreement between MMRDA /MCGM / M/s.Reliance Energy.
- (6) For the above works Mr. Varaskar, Ex. Enginer, Mr. Gajare, Dy. Engineer, (Electrical) from MMRDA will coordinate with Shri Samant from M/s. Reliance Energy and keep informed Shri Sabnis, Chief Engineer, MMRDA and Shri S.C.Deshpande, Jt. Project Director (TP), MMRDA on day to day basis regarding progress of the works.
- (7) The next review meeting on this issue will be held on 9th January 2015.
