Sub: Minutes of meeting held with Members of G-Block Association and BKC Property Owners Association regarding Celebration of Republic Day-26th January 2015.

A meeting was convened under the Chairmanship of Hon. Metropolitan Commissioner, Mumbai Metropolitan Region Development Authority at 3.00 pm. on Monday the 9th January 2015 to discuss the modalities of celebration of "Republic Day-26th January 2015" with the representatives of G-Block Association and BKC Property Owners Association.

The list of attendees is kept at Annexure-I.

The review was taken accordingly to the points mentioned in minutes of the last meeting held on 29th December 2015.

The points and discussions are as follows:

1) Clean BKC Campaign: It was decided to have "Clean -BKC Campaign" from 19th January to 23rd January 2015 and all the Organizations in BKC shall participate voluntarily in the Campaign. On 22nd January 2015 from 3.00 to 6.00 pm all the Organizations shall demonstrate their participation Press will be invited to cover the event and wide publicity will be given for "Clean BKC Campaign". All Organizations shall inform their employees about "Mass Clean BKC Drive" on 22nd January 2015 from 3.00 to 6.00 pm. Special efforts will be taken to involve School Children in BKC. MMRDA will also undertake the drive through its Engineering Division for BKC and its employees in MMRDA building. The logistics required for the cleanliness will be organized by the respective Organizations. **(Action : Both Associations ,Chief Engineer, MMRDA, JPD-PR).**

2) Cleanliness of BKC: The Cleanliness Drive in BKC shall include colouring of Kerb Stones, removing of debris, clearing all Solid Waste, undertaking reinstatement of utilities etc. before 23rd January 2015. **(Action: Chief Engr. MMRDA)**

3) Decoration of BEST Buses: Regarding this, MMRDA has already approached BEST and it will follow-up with BEST regarding the same. The decoration work shall be done through Event Manager engaged by both the Associations. The payment to Event Manager for Decoration of BEST buses shall be made by MMRDA. The Public Relation Department of MMRDA will co-ordinate with Event Manager. **(Action : JPD-PR, MMRDA)**

4) Cricket Matches: MMRDA, MCA and both Associations shall finalize the Cricket Match Schedule and its structure and matches be organized on Saturday and Sunday preferably before 26th January 2015. **(Action: Both Associations, JPD-TP, MMRDA).**

5) Area Lighting: The Associations agreed to undertake Lighting of roads apart from individual building lighting. M/s Reliance Energy shall give a separate connection to the Contractors hired by the Associations for the Area Lighting. M/s. Reliance Energy shall consider giving power supply for area lighting on complimentary basis. The Contractors of the Associations and M/s. Reliance Energy shall co-ordinate on this. **(Action: Both Associations, M/s. Reliance Energy).**

6) Colouring of Electric Poles: M/s. Reliance Energy agreed to colour Electric Poles and undertake repairs of faulty lamps in BKC. This operation shall be completed by 20th January 2015. M/s. Reliance Energy shall also undertake trimming of trees to avoid shadows of lamps on the roads. **(Action: Chief Engr. MMRDA).**

7) Landscaping of the area: All the sponsors are already requested by MMRDA to undertake trimming and replanting of the Landscaping portion and also ensure that the Water-Fountains are maintained and illuminated for a week following 26th January 2015. **(Action: JPD-TP, MMRDA).**

8) Brand Ambassadors: All the Corporate Houses agreed to request their Brand Ambassadors to be present during the Cultural Event programme on 26th January 2015 and also during the "Clean BKC Drive" on 22nd January 2015 between 3.00 to 6.00 pm. **(Action: Both Assocaitions).**

9) Invitation to the Families: All the Corporate agreed to invite their families to the Cultural Programme on 26th January 2015 evening (**Action: Both Associations**).

10) Cultural Programme: The Associations agreed for Cultural Program between 7.00 pm to 10 pm including fireworks show, laser show, and Patriotic Music and Patriotic performances with leading Singers from Bollywood to be arranged on 26/01/2015. The Associations requested that MMRDA shall give wide publicity to the event and also requested to facilitate Police Permission and provide their security for the event. MMRDA agreed to support this event by complimentary land allocation and giving wide publicity through Radio/FM/Print Media. (**Action: JPD- PR, MMRDA**) M/s. Reliance Energy shall consider power supply allocation on complimentary basis for Cultural programme. (**Action: DMC- Land, & JPD-PR MMRDA**)

11) Arrangement of Floats: The Joint Project Director (PR), MMRDA shall coordinate and obtain permission from Protocol Department to bring floats to BKC as it was arranged last year. The floats shall be added attraction to the Cultural programme evening on 26th January 2015 . (**Action: DMC- Lands, JPD-PR MMRDA**).

12) Contributory Approach: It was decided that a separate bank account shall be opened by both the Associations and shall be regulated by both the Associations in a transparent way and MMRDA shall write to all the organizations to give their financial support to this event and utilize this account by the Association for depositing the contribution of the each Organization. (**Action: JPD- TP, MMRDA**)

13) Invitations: It was decided that the Associations, Organizations and MMRDA will request the Hon. Chief Minister to grace the evening function on 26th January 2015 and also to visit various buildings and area Illuminated in BKC etc. (**Action: JPD- TP, MMRDA**)

14) MMRDA Building: The decoration of the MMRDA building will be undertaken by Engineering Division of MMRDA by inviting quotations and the same shall be completed after approval of Hon. M.C. before 25th January 2015

and the rates finalized by MMRDA shall be communicated to both the Associations for their necessary action along with list of Contractors. **(Action: Chief Engineer, MMRDA)**




