## Foot Note:

- 1. The candidature of a person in waiting list is provisional, subject to verification of documents, such as educational qualification, caste certificate, domicile certificate, non-creamy layer certificate and other relevant documents. Those candidates who will not fulfil the criteria as per the notification of recruitment of respective posts or not able to produce the documents in support of their claim their candidature will be rejected.
- 2. Documents for the candidates selected against the horizontally reserved vacancies will be subject to verification by the concerned competent authorities.
- 3. Selected candidates shall be called as per the reservation roster point and in the order of merit, for document verification and subsequent process as per the progress of the project and actual need in a phased manner.
